Contributions or gifts to this association are not deductible as charitable contributions for federal income tax purposes. However, dues are deductible by members as an ordinary and necessary business expense. However, the 1993 Federal Budget Reconciliation Act proclaimed that lobbying expenses are not deductible by individuals and corporations. Accordingly, because the Association will spend a portion of its yearly budget on lobbying, only 96% of your dues can be deducted as an ordinary business expense.
